## **Introduction To Terror Course Level 1**

Terrorism is a tool (or tactic) which is part of the larger strategy used by the N.W.O. They use terrorism to make the citizens of the world scared and then accept the solutions offered by the N.W.O. to make the terror stop. There is some terrorism that is not committed by the N.W.O. but that is a small percentage of the terrorism committed. One famous example of accepting their solutions to the problems they created is the patriot act that was passed after the September 11, 2001 attack on America.

The focus of Terror Course Level 1 at Infowar School is the use of terrorism by the N.W.O. to:

1. Start setting up their technocracy.
2. To destroy the constitution of America.
3. To destroy the bill of rights.
4. To label Christians (of the original text) as terrorists to stop them from spreading the truth.
5. To create mass immigration of Muslims into Europe and the western American continent to create the conditions for a holy war with Muslims and communists fighting against Christians and Jews.

The N.W.O. strategy happens in steps with one step laying out the foundation for the next step and you can see their plan unfold when you put the events on a timeline. We will look at the time period of the N.W.O. strategy from the year 1898 until 2021. During this time period there have been many events created by the N.W.O. where they used terrorism and have been caught using it. All these events show a clear pattern of the N.W.O. using terrorism to fulfill their plan.

This time period of the N.W.O. plan from 1898 until 2021 involves the three world divisions which are Muslims, Communists and Judeo-Christians. These three main groups of people are used against each other all the time. The N.W.O. uses wars very often to change things they don't like such as who is in control of a country by killing the leaders and the populations that resist them. They used wars to create a reason to set up the United Nations which is their world government. In this course We will look at the steps they have taken to carry out their plan by using terrorism and by causing wars.

Reaching their goals has been a long process that has taken centuries and is still ongoing. Now in the year 2021, The N.W.O. is calling real American patriots and patriots from other countries terrorists and is even arresting them and putting them in jail.

### **Two Admitted Examples Of False Flag Terror**

To help you understand that the N.W.O. are terrorists, we will look at two undeniable and admitted examples of their terrorism and then we will follow the timeline of their activities from 1898 until 2021 to understand their plan. The two admitted examples of their terrorism are Operation Northwoods and Operation Gladio.

Operation Northwoods was a plan to lie about Cuba and create a reason for America to Invade Cuba. Operation Gladio was a campaign of terror in Europe created by NATO that killed many innocent people in Europe.

### Operation Gladio

Operation Gladio was a huge operation in Europe under the control of NATO that did many things. One of the things it did was commit acts of terrorism to take more control of society through security legislation. This is one of the methods the N.W.O. uses to take total control of society. Right-wing terrorist Vinciguerra, who like others with contacts to the Gladio branch of the Italian military secret service, had been killed for his political conviction, related:

**'You had to attack civilians, the people, women, children, innocent people, unknown people far removed from any political game.'** The reason was quite simple. **'They were supposed to force these people, the Italian public, to turn to the State to ask for greater security.'** This is the political logic that lies behind all the massacres and the bombings which remain unpunished, because the State cannot convict itself or declare itself responsible for what happened.

The United States was involved in funding Gladio. A former CIA director admitted to it in an interview as reported by the Washington Post:

In a television interview on Italy's Channel 4, former **CIA director William Colby confirmed the U.S. role in Italy's secret army** and described how he was sent to Stockholm in 1951 to set up a similar network in Scandinavia.

Colby, who headed the CIA from 1973 to 1976, also revealed that U.S. intelligence agencies channeled large sums to Italy's right-of-center Christian Democrats and other "anti-Communist" political parties during the Cold War era -- a connection that has long been alleged by Italy's left-wing parties. The money, said Colby, was used to ensure that Italy did not "fall into Communist hands."

1969 In Italy, the Piazza Fontana massacre in Milan **kills 16 and injures and maims 80 and is blamed on the left**. Thirty years later during a trial of right-wing extremists General Giandiego Maletti, former head of Italian counterintelligence, alleges that **the massacre had been carried out by the Italian stay-behind army and right-wing terrorists on the orders of the US secret service CIA in order to discredit the Italian Communists.**


As you can see from operation Gladio, many of our world leaders are terrorists and they work together from different sides of wars or conflicts pretending to be enemies but it is all an act that they use to build their N.W.O.

Operation Northwoods

Cuba is a communist country and communism is not good at all but creating a false flag (fake attack) as an excuse to attack another country is never the thing to do. If a country is really so bad, you don't need to fake anything. This false flag attack against America was supposed to result in a military attack against Cuba but the plan was never used because President Kennedy said no to it.

We will be looking at Operation Northwoods because it is a clear and admitted example of a false flag but also because it is very similar to the attacks of 9-11. It is important to study this topic first for people who still believe the official story of 9-11 because that official story is a proven lie. The amazing thing about the 9-11 attack is the official story proves itself wrong and impossible which you will see in level 2 of the terror course.

Operation Northwoods also helps us to see the tactics that the N.W.O. will use and the levels of people involved in a conspiracy like this false flag attack. These tactics show up over and over in N.W.O. activities. This topic should help you realize that there are evil people in governments all around the world.



### The Purpose Of Operation Northwoods

The purpose of the Operation Northwoods is to create a reason for going to war with Cuba. Obviously there was no reason to go to war with Cuba so the N.W.O. was creating a reason that did not already exist. It is very important to remember that the N.W.O. created communism and wanted Cuba to become communist. They are always creating one problem that leads to another problem and another and on and on as they build the N.W.O. it is called problem reaction solution. It is our reactions to their problems that build the N.W.O. one piece at a time. It is difficult to know exactly why they wanted to have a military conflict with Cuba because it never happened the way they planned but later on there was a lot of activity in South America that lead to Iran contra and the crack cocaine problem in America so maybe Operation Northwoods would have lead to similar outcomes.

5. The suggested courses of action appended to Enclosure A are based on the premise that **US military intervention will result** from a period of heightened US-Cuban tensions which **place the United States in the position of suffering justifiable grievances**. World opinion, and the United Nations forum should be favorably affected by developing the international image of the Cuban government as rash and irresponsible, and as an alarming and unpredictable threat to the peace of the Western Hemisphere.

Similar to Operation Northwoods, the 9-11 attacks were designed to create a reason to go to war with Afghanistan and Iraq and finally lead to a wider Middle East war in places like Libya and Syria. Those wars would lead to people who control those countries who are favorable to the N.W.O.

There were several other goals that the 9-11 attacks were meant to lead to like introducing counter terrorism legislation in the United States that is now being used against American citizens who resist the N.W.O. The war on terror set up a world wide surveillance grid that is now being used as part of a technocracy that controls citizens in their own countries.



b. We could blow up a drone (unmanned) vessel anywhere in the Cuban waters. We could arrange to cause such incident in the vicinity of Havana or Santiago as a spectacular result of Cuban attack from the air or sea, or both. The presence of Cuban planes or ships merely investigating the intent of the vessel could be fairly compelling evidence that the ship was taken under attack. The nearness to Havana or Santiago would add credibility especially to those people that might have heard the blast or have seen the fire. The US could follow up with an air/sea rescue operation covered by US fighters to "evacuate" remaining members of the non-existent crew. Casualty lists in US newspapers would cause a helpful wave of national indignation.

If the plan had been used there would have been witnesses to fake distress calls and exploding ships and planes. Those witnesses would have made assumptions based on staged circumstances that would have lead them to the wrong conclusions about what happened. Then the witnesses would report their assumptions. For example they would say "I heard a distress call and saw an explosion and there were Cuban planes and Cuban ships near the explosion. The Cubans must have attacked and sunk that ship." But in reality the plan was to send a remote controlled empty ship into Cuban waters near a big city and blow it up after Cuban authorities showed up to investigate the unidentified ship in their territory. The Americans would not even have to say anything. The story of Cuba being responsible would have started with the Cuban witness assumptions which would help the Americans sell their lie.

### Other Types Of Conspirators

If the plan was approved there would have been more people involved. These people may not have known about the entire plan or its ultimate objectives but they would have known they were involved in a lie. There would have been Cubans that were allied with the Americans that would have known about some parts of the plan like their roles in pretending to attack the American base at Guantanamo Bay.

There would have been a few pilots that knew they were involved in deceptive activities designed to frame Cuba and a small amount of people at Elgin air force base that would be involved in painting and renumbering planes.

These low level conspirators would not likely know about the N.W.O. slowly taking over the world. Instead they would be told lies to justify their own lies. They would likely be told that the communists are so evil and deadly that having this smaller war would prevent a larger war and save thousands of lives but no matter what happens people will die. It's just a matter of saving as many lives as possible.

But as we already know the people who created Operation Northwoods and the people who created communism are all part of the N.W.O. It's always problem reaction solution being used against us to put N.W.O. people into power as the solution to their wars and to control the world.

8. It is possible to create an incident which will demonstrate convincingly that a **Cuban aircraft has attacked and shot down a chartered civil airliner** enroute from the United States to Jamaica, Guatemala, Panama or Venezuela. The destination would be chosen only to cause the flight plan route to cross Cuba. The passengers could be a group of college students off on a holiday or any grouping of persons with a common interest to support chartering a non-scheduled flight.

a. An aircraft at Eglin AFB would be painted and numbered as an exact duplicate for a civil registered aircraft belonging to a CIA proprietary organization in the Miami area. At a designated time the duplicate would be substituted for the actual civil aircraft and would be loaded with the selected passengers, all boarded under carefully prepared aliases. The actual registered aircraft would be converted to a drone.

b. Take off times of the drone aircraft and the actual aircraft will be scheduled to allow a rendezvous south of Florida. From the rendezvous point the passenger-carrying aircraft will descend to minimum altitude and go directly into an auxiliary field at Eglin AFB where arrangements will have been made to evacuate the passengers and return the aircraft to its original status. The drone aircraft meanwhile will continue to fly the filed flight plan. When over Cuba the drone will be transmitting on the international distress frequency a "MAY DAY" message stating he is under attack by Cuban MIG aircraft. The transmission will be interrupted by destruction of the aircraft which will be triggered by radio signal. This will allow ICAO radio stations in the Western Hemisphere to tell the US what has happened to the aircraft instead of the US trying to "sell" the incident.

### The N.W.O. Are Willing To Go To Great Lengths To Create An Entire False Story

Operation Northwoods planned to make Cuba look like it was a danger to America and to the other countries around it. They wrote that there should be a logical buildup of events with seemingly unrelated incidents used to hide the ultimate goal of falsely setting up Cuba to be attacked. These incidents would be listed later on in the Northwoods memo and will be shown in the following paragraphs but the important point to note now is that the N.W.O. is willing to go to great trouble to create a false timeline of events that are supposed to lead to what they want. They would even stage a fake debate in the government to publicize all kinds of bad things about Cuba even if it was a debate of lies. All of this is supposed to make Cuba look like the aggressive dangerous bad guy and America look like the victim that has absolutely no choice but to use force to defend itself.

3. This plan, incorporating projects selected from the attached suggestions, or from other sources, should be developed to focus all efforts on a specific ultimate objective which would provide adequate justification for US military intervention. Such a plan would enable a logical build-up of incidents to be combined with other seemingly unrelated events to camouflage the ultimate objective and create the necessary impression of Cuban rashness and irresponsibility on a large scale, directed at other countries as well as the United States. The plan would also properly integrate and time phase the courses of action to be pursued.

The desired resultant from the execution of this plan would be to place the United States in the apparent position of suffering defensible grievances from a rash and irresponsible government of Cuba and to develop an international image of a Cuban threat to peace in the Western Hemisphere.

9. It Is possible to create an incident which will make it appear that Communist Cuban MIGs have destroyed a USAF aircraft over international waters in an unprovoked attack.

a. Approximately 4 or 5 F-101 aircraft will be dispatched in trail from Homestead AFB, Florida, to the vicinity of Cuba. Their mission will be to reverse course and simulate fakir aircraft for an air defense exercise in southern Florida. These aircraft would conduct variations of these flights at frequent intervals. Crews would be briefed to remain at least 12 miles off the Cuban coast; however, they would be required to carry live ammunition in the event that hostile actions were taken by the Cuban MIGs.

b. On one such flight, a pre-briefed pilot would fly tail-end Charley at considerable interval between aircraft. While near the Cuban Island this pilot would broadcast that he had been jumped by MIGs and was going down. No other calls would be made. The pilot would then fly directly west at extremely low altitude and land at a secure base, an Eglin auxiliary. The aircraft would be met by the proper people, quickly stored and given a new tail number. The pilot who had performed the mission under an alias, would resume his proper identity and return to his normal place of business. The pilot and aircraft would then have disappeared.

c. At precisely the same time that the aircraft was presumably shot down a submarine or small surface craft would disburse F-101 parts, parachute, etc., at approximately 15 to 20 miles off the Cuban coast and depart. The pilots returning to Homestead would have a true story as far as they knew. Search ships and aircraft could be dispatched and parts of aircraft found.

Just like the 9-11 attacks America was made to look like the victim just like the first time the world trade center was bombed. That was blamed on Usama but as we found out it was another set up because Imad Salem secretly taped his conversations with the FBI. The tapes revealed that the FBI knew it was a real bomb but let the attack take place anyway. Not everyone in the FBI is part of the N.W.O. but there are N.W.O. agents all over in key positions so that they can control what happens.

### Tactics From Operation Northwoods To Use Against Cuba

In the Operation Northwoods memo there are five smaller false flag operations that are suggested for use in leading up to the attack on Cuba. These smaller individual operations are the specific actions they wanted to take to make Cuba look like a danger. We will now look at them one at a time and note the similarities to the 9-11 attacks which will help you to accept and believe that there are people in the American government and all around the world that are members of the N.W.O. and they will do anything to build their final and complete N.W.O. Most or all of these tactics would have been used to carryout Operation Northwoods.

#### Use A Military Exercise to Scare Cuba into Defending Itself

The first tactic mentioned in the Northwoods memo is to scare Cuba into attacking America by having the American military conduct practice invasions of Cuba that look so real that Cuba will think they are real and will then defend itself with force. The American military exercise is supposed to be ready to become a real military action if Cuba takes the bait. And to help the chances of scaring Cuba enough that it does attack, they U.S. military would harass and deceive the Cubans in various ways that would not normally be used in a military exercise.

1. Since it would seem desirable to use legitimate provocation as the basis for US military intervention in Cuba a cover and deception plan, to include requisite preliminary actions such as has been developed in response to Task 33 c, could be executed as an initial effort to provoke Cuban reactions. Harassment plus deceptive actions to convince the Cubans of imminent invasion would be emphasized. Our military posture throughout execution of the plan will allow a rapid change from exercise to intervention if Cuban response justifies.

In the time leading up to and on the day of the 9-11 attacks there were several exercises that simulated the exact attack that happened. As you can clearly see, military exercises are used to practice a real attack and provide cover for the people who are acting in a criminal way to make the attack happen.

#### Create A Series Of Fake Incidents Around The American Base At Guantanamo Bay And Blame The Cubans For It

Another tactic that would be used to justify attacking Cuba was to use friendly Cubans who were allied to the Americans to pretend to attack the Americans which would lead to the Americans retaliating against the real Cubans. As you can see from this tactic it is totally an act with no enemy Cubans involved. The Americans and their 'friendly' Cubans would be the only people involved and it would have absolutely nothing to do with the communist Cuban army but the communist Cubans would be blamed and attacked and killed. It is a lie and a set up. Some Americans and their 'friendly' Cubans would no doubt be killed and wounded in all the chaos as well. 2. A series of well coordinated incidents will be planned to take place in and around Guantanamo **to give genuine appearance of being done by hostile Cuban forces.**

a. Incidents to establish a credible attack (not in chronological order):

(1) Start rumors (many). Use clandestine radio.

(2) Land **friendly Cubans in uniform** "over-the-fence" to stage attack on base.

(3) Capture Cuban **(friendly) saboteurs inside the base.**

(4) Start riots near the base main gate (**friendly Cubans**).

(5) Blow up ammunition inside the base; start fires.

(6) Burn aircraft on air base (sabotage).

(7) Lob mortar shells from outside of base into base. Some damage to installations.

(8) Capture assault teams approaching from the sea or vicinity of Guantanamo City.

(9) Capture militia group which storms the base.

(10) Sabotage ship in harbor; large fires -- naphthalene.

(11) Sink ship near harbor entrance. **Conduct funerals for mock-victims** (may be lieu of (10)).

b. **United States would respond by executing offensive operations** to secure water and power supplies, destroying artillery and mortar emplacements which threaten the base.

c. Commence large scale United States military operations.

From this part of the Northwoods memo we can see that the Americans in the N.W.O. are willing to attack themselves using their own people pretending to be hostile. As you may already know, Usama and Al-Qaeda were created by the CIA and worked for the Americans for a long time before 9-11. Was the N.W.O. in America using its own people to attack itself?

### Sink A Ship And Blame It On Cuba

This tactic was used before on more than one occasion. This tactic called for the sinking of an empty remote controlled ship near a large Cuban city and it would be blamed on Cuba. There would be a fake search for non existent survivors and fake casualty lists would be published in the American news papers causing anger against Cuba that would help justify going to war. The ship would be sailed close to a major city and then only after Cuban planes and ships came to investigate the unknown ship would it be blown up by remote control. The people in the Cuban cities would have seen and heard the explosion and the Cuban ships and planes near the empty ship would be enough to make people think Cuba attacked the empty ship. Cuban citizens would very likely be tricked into believing their own country was responsible and their testimony of just seeing their planes and ships near the explosion would help sell the American N.W.O. lie.

3. A "Remember the Maine" incident could be arranged in several forms:

a. We could blow up a US ship in Guantanamo Bay and blame Cuba.

b. **We could blow up a drone (unmanned) vessel anywhere in the Cuban waters.**

We could arrange to cause such incident in the vicinity of Havana or Santiago as a spectacular result of Cuban attack from the air or sea, or both.

**The presence of Cuban planes or ships merely investigating the intent of the vessel could be fairly compelling evidence that the ship was taken under attack.**

The nearness to Havana or Santiago would add credibility especially to those people that might have heard the blast or have seen the fire. The US could follow up with an air/sea rescue operation covered by US fighters to "evacuate" remaining members of the non-existent crew. Casualty lists in US newspapers would cause a helpful wave of national indignation.

What is important here is to note how the N.W.O. will use people's assumptions to their advantage. Even though no one could have seen Cuba attack the ship because they didn't attack it, they will assume they didn't see it because they were too far to see the rockets or torpedoes and that the attack really did happen. After the 9-11 attacks most people assumed the buildings fell because of fires and the damage from the planes but that's not what happened. The N.W.O. knows most people don't understand engineering and will assume the government is telling them the truth. All they have to do after is to discredit real engineers who explain what really happened by calling them crazy conspiracy theorists and by using their institutions like NIST and the media to lie and support the N.W.O. story.

**Create A Campaign Of Terror In Florida And Surrounding States And In Washington**

In this tactic they actually planned to kill and wound innocent people. This plan called for creating a fake communist terror campaign against America to be blamed on Cuba. There are people who don't want to live in Cuba because they don't want to live under communism so they try to escape to America on boats. Then American N.W.O. members would pretend to be Cuban communists that were targeting the immigrants as traitors for leaving Cuba. They would then sink some of their boats and kill some of them to make Cuba look evil. At the same time America would encourage more immigrants to leave Cuba by plane and boat to make sure there are more targets or else emigration might stop due to fear. 4. **We could develop a Communist Cuban terror campaign in the Miami area**, in other Florida cities and even in Washington. The terror campaign could be pointed at refugees seeking haven in the United States. **We could sink a boatload of Cubans enroute to Florida (real or simulated)**. We could foster attempts on lives of Cuban refugees in the United States even **to the extent of wounding in instances to be widely publicized**. **Exploding a few plastic bombs in carefully chosen spots**, the arrest of Cuban agents and the release of prepared documents substantiating Cuban involvement, also would be helpful in projecting the idea of an irresponsible government.

5. A "Cuban-based, Castro-supported" filibuster could be simulated against a neighboring Caribbean nation (in the vein of the 14th of June invasion of the Dominican Republic). We know that Castro is backing subversive efforts clandestinely against Haiti, Dominican Republic, Guatemala, and Nicaragua at present and possible others. These efforts can be magnified and additional ones contrived for exposure. For example, advantage can be taken of the sensitivity of the Dominican Air Force to intrusions within their national air space. "Cuban" B-26 or C-46 type aircraft could make cane-burning raids at night. Soviet Bloc incendiaries could be found.

This could be coupled with "Cuban" messages to the Communist underground in the Dominican Republic and "Cuban" shipments of arm which would be found, or intercepted, on the beach.

From this tactic we can see that America is willing to attack itself and kill its own citizens by using terrorism. The bombs planned for Florida and Washington would have likely killed Americans. You will see later in this course and in other parts of the terror course that America has already killed its own citizens to terrorize its citizens into doing what the N.W.O. wants them to do.

#### Fake An Attack On A Civilian Airliner By Cubans

8. It is possible to create an incident which will demonstrate convincingly that a Cuban aircraft has attacked and shot down a chartered civil airliner enroute from the United States to Jamaica, Guatemala, Panama or Venezuela. The destination would be chosen only to cause the flight plan route to cross Cuba. The passengers could be a group of college students off on a holiday or any grouping of persons with a common interest to support chartering a non-scheduled flight.

a. An aircraft at Eglin AFB would be painted and numbered as an exact duplicate for a civil registered aircraft belonging to a CIA proprietary organization in the Miami area. At a designated time the duplicate would be substituted for the actual civil aircraft and would be loaded with the selected passengers, all boarded under carefully prepared aliases. The actual registered aircraft would be converted to a drone.

b. Take off times of the drone aircraft and the actual aircraft will be scheduled to allow a rendezvous south of Florida. From the rendezvous point the passenger-carrying aircraft will descend to minimum altitude and go directly into an auxiliary field at Eglin AFB where arrangements will have been made to evacuate the passengers and return the aircraft to its original status. The drone aircraft meanwhile will continue to fly the filed flight plan. When over Cuba the drone will be transmitting on the international distress frequency a "MAY DAY" message stating he is under attack by Cuban MIG aircraft. The transmission will be interrupted by destruction of the aircraft which will be triggered by radio signal. This will allow ICAO radio stations in the Western Hemisphere to tell the US what has happened to the aircraft instead of the US trying to "sell" the incident.

On 9-11 something similar to this happen. Two allegedly high jacked planes crossed over Stewart air National Guard base in New York State at the same time and shut off their transponders then later crashed into the twin towers. Could it have been a drone remote controlled that left Stewart AFB after the two planes were switched? There is also evidence that flight 77? Didn't actually hit the pentagon either. The evidence shows that it was more likely that flight 77 flew over the pentagon and explosives were detonated at the same time. Then flight 77 turned right and flew low level and joined the airplanes leaving the airport that is right next door to the pentagon. Sound strange and unbelievable? How's Operation Northwoods sound? Normal?

### Pretend To Shoot Down American Air Force Jet

This tactic is another case of totally framing Cuba for something it didn't do. This is what the plan was for the event:

9. It is possible to create an incident which will **make it appear that Communist Cuban MIGs have destroyed a USAF aircraft** over international waters in an unprovoked attack.

a. Approximately 4 or 5 F-101 aircraft will be dispatched in trail from Homestead AFB, Florida, to the vicinity of Cuba. Their mission will be to reverse course and simulate fakir aircraft for an air defense exercise in southern Florida. These aircraft would conduct variations of these flights at frequent intervals.

Crews would be briefed to remain at least 12 miles off the Cuban coast; however, they would be required to carry live ammunition in the event that hostile actions were taken by the Cuban MIGs.

b. On one such flight, a pre-briefed pilot would fly tail-end Charley at considerable interval between aircraft. While near the Cuban Island this pilot would broadcast that he had been jumped by MIGs and was going down. No other calls would be made. The pilot would then fly directly west at extremely low altitude and land at a secure base, an Eglin auxiliary. The aircraft would be met by the proper people, quickly stored and given a new tail number. The pilot who had performed the mission under an alias, would resume his proper identity and return to his normal place of business. The pilot and aircraft would then have disappeared.

c. At precisely the same time that the aircraft was presumably shot down a submarine or small surface craft would disburse F-101 parts, parachute, etc., at approximately 15 to 20 miles off the Cuban coast and depart. The pilots returning to Homestead would have a true story as far as they knew. Search ships and aircraft could be dispatched and parts of aircraft found.

The important points to note are: the pilot's involvement, fake wreckage was to be placed at the scene, and a very deceptive part was to trick others into being involved in the lie by letting the people who heard the fake distress call report what supposedly happened. This makes them into unknowing conspirators. This has a similarity to what likely happened at the pentagon on 9-11 because the employed pilot of American airlines who flew flight 77 used to work at the pentagon in the exact spot where it was hit. But there is evidence the plane just flew over the pentagon and explosives did the damage. The placement of fake wreckage and a parachute is very deceitful and shows us just how far the N.W.O. is willing to go to make us believe in their lies.

As you can see from operation Northwoods, many of our world leaders are terrorists and they work together from different sides of wars or conflicts pretending to be enemies but it is all an act that they use to build their N.W.O.

## False Flag Terror

Most people are tricked into following the N.W.O. plan even though they are good people. It is important to remind ourselves that the N.W.O. is a group of people separate from the nations of our world who have infiltrated us and who are trying to build what they call a N.W.O. where they are in control of every single thing on earth. Their agents are operating in every country so don't forget that most people are tricked into following their N.W.O. plan even though they are good people.

A false flag attack is a tool used by the N.W.O. to frame people for something they didn't do. Then the N.W.O. will use the lie of the false flag they created to justify their actions. ### Manchurian Incident

Japanese troops set off a small explosion on a train track in 1931, and falsely blamed it on China in order to justify an invasion of Manchuria. This is known as the “Mukden Incident” or the “Manchurian Incident”. The Tokyo International Military Tribunal found: “Several of the participants in the plan, including Hashimoto [a high-ranking Japanese army officer], have on various occasions admitted their part in the plot and have stated that the object of the ‘Incident’ was to afford an excuse for the occupation of Manchuria by the Kwantung Army

### Gleiwitz Incident

A major with the Nazi SS admitted at the Nuremberg trials that – under orders from the chief of the Gestapo – he and some other Nazi operatives faked attacks on their own people and resources which they blamed on the Poles, to justify the invasion of Poland.

### Reistag Fire

Nazi general Franz Halder also testified at the Nuremberg trials that Nazi leader Hermann Goering admitted to setting fire to the German parliament building in 1933, and then falsely blaming the communists for the arson.

### Winter War

Soviet leader Nikita Khrushchev admitted in writing that the Soviet Union’s Red Army shelled the Russian village of Mainila in 1939 – while blaming the attack on Finland – as a basis for launching the “Winter War” against Finland. Russian president Boris Yeltsin agreed that Russia had been the aggressor in the Winter War.

### Joseph Stalin Ordered His Secret Police To Execute 22,000 Polish Army Officers

The Russian Parliament, current Russian president Putin and former Soviet leader Gorbachev all admit that Soviet leader Joseph Stalin ordered his secret police to execute 22,000 Polish army officers and civilians in 1940, and then falsely blamed it on the Nazis.

### Operation Embarrass

The British government admits that – between 1946 and 1948 – it bombed 5 ships carrying Jews attempting to flee the Holocaust to seek safety in Palestine, set up a fake group called “Defenders of Arab Palestine”, and then had the psuedo-group falsely claim responsibility for the bombings.

### Lavon Affair

Israel admits that in 1954, an Israeli terrorist cell operating in Egypt planted bombs in several buildings, including U.S. diplomatic facilities, then left behind “evidence” implicating the Arabs as the culprits (one of the bombs detonated prematurely, allowing the Egyptians to identify the bombers, and several of the Israelis later confessed).

### Cia Overthrew Iran

The CIA admits that it hired Iranians in the 1950's to pose as Communists and stage bombings in Iran in order to turn the country against its democratically-elected prime minister

### 1955 Bombing On A Turkish Consulate In Greece

The Turkish Prime Minister admitted that the Turkish government carried out the 1955 bombing on a Turkish consulate in Greece – also damaging the nearby birthplace of the founder of modern Turkey – and blamed it on Greece, for the purpose of inciting and justifying anti-Greek violence

### Eisenhower Doctrine

The British Prime Minister admitted to his defense secretary that he and American president Dwight Eisenhower approved a plan in 1957 to carry out attacks in Syria and blame it on the Syrian government as a way to effect regime change

### Operation Gladio

The former Italian Prime Minister, an Italian judge, and the former head of Italian counterintelligence admit that NATO, with the help of the Pentagon and CIA, carried out terror bombings in Italy and other European countries in the 1950s and blamed the communists, in order to rally people's support for their governments in Europe in their fight against communism. As one participant in this formerly-secret program stated:

“You had to attack civilians, people, women, children, innocent people, unknown people far removed from any political game. The reason was quite simple. They were supposed to force these people, the Italian public, to turn to the state to ask for greater security.”

Italy and other European countries subject to the terror campaign had joined NATO before the bombings occurred. They also allegedly carried out terror attacks in France, Belgium, Denmark, Germany, Greece, the Netherlands, Norway, Portugal, the UK, and other countries.

False flag attacks carried out pursuant to this program include – by way of example only:

- The murder of the Turkish Prime Minister (1960)
- Bombings in Portugal (1966)
- The Piazza Fontana massacre in Italy (1969)
- Terror attacks in Turkey (1971)
- The Peteano bombing in Italy (1972)
- Shootings in Brescia, Italy and a bombing on an Italian train (1974)
- Shootings in Istanbul, Turkey (1977)
- The Atocha massacre in Madrid, Spain (1977)
- The abduction and murder of the Italian Prime Minister (1978)
- The bombing of the Bologna railway station in Italy (1980)
- Shooting and killing 28 shoppers in Brabant county, Belgium (1985)

In 1960, American Senator George Smathers suggested that the U.S. launch “a false attack made on Guantanamo Bay which would give us the excuse of actually fomenting a fight which would then give us the excuse to go in and [overthrow Castro]”

As admitted by the U.S. government, recently declassified documents show that in 1962, the American Joint Chiefs of Staff signed off on a plan to **blow up AMERICAN airplanes** (using an elaborate plan involving the switching of airplanes), and also to **commit terrorist acts on American soil**, and then to blame it on the Cubans in order to justify an invasion of Cuba. A U.S. Congressional committee admitted that – as part of its “Cointelpro” campaign – the FBI had used many provocateurs in the 1950s through 1970s to carry out violent acts and falsely blame them on political activists

### Burned Down A Mosque

A top Turkish general admitted that Turkish forces burned down a mosque on Cyprus in the 1970s and blamed it on their enemy. He explained: “In Special War, certain *acts of sabotage are staged and blamed on the enemy* to increase public resistance. We did this on Cyprus; we even burnt down a mosque.” In response to the surprised correspondent’s incredulous look the general said, “I am giving an example”

### Cia Trained Foreign Police And Troops To Make Booby Traps

A declassified 1973 CIA document reveals a program to train foreign police and troops on how to make booby traps, pretending that they were training them on how to investigate terrorist acts:

The Agency maintains liaison in varying degrees with foreign police/security organizations through its field stations ....

[CIA provides training sessions as follows:]

- a. Providing trainees with basic knowledge in the uses of commercial and military demolitions and incendiaries as they may be applied in terrorism and industrial sabotage operations.
- b. Introducing the trainees to commercially available materials and home laboratory techniques, likely to be used in the manufacture of explosives and incendiaries by terrorists or saboteurs.
- c. Familiarizing the trainees with the concept of target analysis and operational planning that a saboteur or terrorist must employ.

d. Introducing the trainees to booby trapping devices and techniques giving practical experience with both manufactured and improvised devices through actual fabrication.

The program provides the trainees with ample opportunity to develop basic familiarity and use proficiently through handling, preparing and applying the various explosive charges, incendiary agents, terrorist devices and sabotage techniques

#### Frame Gaddafi As A Terrorist Supporter

A Mossad agent admits that, in 1984, Mossad planted a radio transmitter in Gaddafi's compound in Tripoli, Libya which broadcast fake terrorist transmissions recorded by Mossad, in order to frame Gaddafi as a terrorist supporter. Ronald Reagan bombed Libya immediately thereafter.

False flag terrorist attacks were carried out in Latin America and other regions as part of the CIA's "Dirty Wars".

Similarly, a CIA "psychological operations" manual prepared by a CIA contractor for the Nicaraguan Contra rebels noted the value of assassinating someone on your own side to create a "martyr" for the cause. The manual was authenticated by the U.S. government. The manual received so much publicity from Associated Press, Washington Post and other news coverage that – during the 1984 presidential debate – President Reagan was confronted with the following question on national television:  
At this moment, we are confronted with the extraordinary story of a CIA guerrilla manual for the anti-Sandinista contras whom we are backing, which advocates not only assassinations of Sandinistas but the **hiring of criminals to assassinate the guerrillas we are supporting in order to create martyrs**

#### Kgb Blew Up Apartment Buildings

Senior Russian Senior military and intelligence officers admit that the KGB blew up Russian apartment buildings in 1999 and falsely blamed it on Chechens, in order to justify an invasion of Chechnya.

#### A Fake Macedonia Terror Tale That Led To Deaths

As reported by BBC, the New York Times, and Associated Press, Macedonian officials admit that the government murdered 7 innocent immigrants in cold blood and pretended that they were Al Qaeda soldiers attempting to assassinate Macedonian police, in order to join the "war on terror"

At the July 2001 G8 Summit in Genoa, Italy, black-clad thugs were videotaped getting out of police cars, and were seen by an Italian MP carrying "iron bars inside the police station". ### Warrentless Wire Taps And Torture

Former Department of Justice lawyer John Yoo suggested in 2005 that the US should go on the offensive against al-Qaeda, having “our intelligence agencies create a **false terrorist organization**. It could have its own websites, recruitment centers, training camps, and fundraising operations. It could **launch fake terrorist operations** and claim credit for real terrorist strikes, helping to sow confusion within al-Qaeda’s ranks, causing operatives to doubt others’ identities and to question the validity of communications.”

### Operation Glass Houses

### Quebec Police At Montebello

Quebec police admitted that, in 2007, thugs carrying rocks to a peaceful protest were actually undercover Quebec police officers.

### A 2008 Us Army Special Operations Field Manual

A 2008 US Army special operations field manual recommends that the U.S. military use surrogate non-state groups such as “paramilitary forces, individuals, businesses, foreign political organizations, resistant or insurgent organizations, expatriates, **transnational terrorism adversaries, disillusioned transnational terrorism members**, black marketers, and other social or political ‘undesirables.’” The manual specifically acknowledged that U.S. special operations can involve both counterterrorism and “Terrorism” (as well as “transnational criminal activities, including narco-trafficking, illicit arms-dealing, and illegal financial transactions.”)

In 1891 a newly built American battleship named the USS Maine sailed into Havana Harbor and a few days later there was an explosion that caused it to sink. 266 crew members died. Headlines started casting suspicion onto the Spanish for causing the explosion with a mine or torpedo. Because of that sunken ship, America went to war with Spain and their battle cry was "remember the Maine."

In 2002, the Discovery Channel produced a documentary called, [Unsolved History: death of the USS Maine](#) where they reconstructed part of the hull of the Maine. On Friday morning Edward Mandell House, President Wilson's alter ego, was preparing for an audience with King George V, a meeting that hinted of finalizing a plan to sacrifice the Lusitania in order to draw the United States into the war. As Simpson described it, House met first with Sir Edward Grey, who asked him, "What will America do if the Germans sink an ocean liner with American passengers on board?" House replied, "I believe that a flame of indignation would sweep the United States and that by itself would be sufficient to carry us into the war."

King George V, when he met with House later that day, was more specific, asking, "Colonel, what will America do if the Germans sink the Lusitania?" Apparently House spent the whole day and into the evening with the British elites, as James Perloff reported in "False Flag at Sea — Lusitania":  
At evening, a splendid dinner was given honoring House; numerous British dignitaries attended, including Grey, and — at House's request — Lord Mersey, the Wreck Commissioner who would later oversee the inquiry regarding the Lusitania. During this dinner the news arrived of the great ship's sinking. House announced to the assembled guests that America would enter the war within the month.

### Why Sink The Lusitania?

The Lusitania was sunk to create an excuse for America to enter World War 1 because going to war requires an act of congress to be passed and there has to be a good reason for that to happen. Why would anyone want America to enter World War 1? First, as always, you have to put this event into the proper perspective by considering why the N.W.O. would want this to happen and how they would benefit. ### **1917**

As per the **Rothschild promise to the British, to take America into the war**, they decide they want something in writing from the British to prove that they will uphold their side of the bargain. The British Foreign Secretary, Arthur James Balfour, a Jew, therefore drafts a letter which is commonly known as the, "**Balfour Declaration,**" which is reprinted below. "Foreign Office November 2nd, 1917 Dear Lord Rothschild, I have much pleasure in conveying to you, on behalf of His Majesty's Government, the following declaration of sympathy with Jewish Zionist aspirations which has been submitted to, and approved by, the Cabinet. His Majesty's Government view with favour the **establishment in Palestine of a national home for the Jewish people**, and will use their best endeavours to facilitate the achievement of this object, it being clearly understood that nothing shall be done which may prejudice the civil and religious rights of existing non-Jewish communities in Palestine, or the rights and political status enjoyed by Jews in any other country. I should be grateful if you would bring this declaration to the knowledge of the Zionist Federation. Yours sincerely, Arthur James Balfour."

### **1919**

On January 18th, the Versailles peace conference commences, to decide reparations that the Germans are required to pay to the victors following the end of World War 1. A delegation of 117 Jews headed up by Ashkenazi Jew, Bernard Baruch (who would go on to state to a select committee of the United States Congress, "I probably had more power than perhaps any other man did in the war, doubtless that is true,") bring up the subject of the promise of Palestine for them. At this point the Germans realised why America had turned on them and under whose influence, the Rothschilds'.

Finally, the Rothschilds' also use the Versailles peace conference to set up their second overt attempt at world government, which they promote under the pretext of ending all wars (which they of course create). They call this the, "**League of Nations.**"

### Setting Up the Lusitania Before the Attack

Without careful preparation the Lusitania would never have been attacked by Germany. Let's look at the way the N.W.O. members manipulated the situation to create the conditions where the Lusitania could be attacked. Remember that the N.W.O. has members on all sides and that they play their parts very well because they have to make all the soldiers and sailors and citizens of the countries at war believe what they are seeing is real and not planned. We know there are N.W.O. people on the American and British side of this event because of their actions but the people in power on the German side could have easily and even likely played a role in helping America into the war, bringing about the results which benefit the N.W.O.

Let's first look at the actions of the German sailors at the beginning of the war. The sailors are almost certainly not N.W.O. members. And then we will go through the steps taken to set up the Lusitania to be attacked.

At first, **German U-boats were obedient to the Cruiser Rules of naval warfare.** Unarmed passenger ships were not to be sunk. Unarmed cargo ships of belligerent nations could be sunk or towed away as a prize of war once the crew was allowed to radio a distress call for rescue and abandon ship. The passengers and crew were considered to be in safety in their lifeboats if they were near land or on a neutral vessel. Armed warships or merchant vessels that were a threat to the U-boat could be sunk without warning.

The February 1, 1915 issue of the New York Times had a front-page article in which British civilian sailors from unarmed merchant vessels explained in detail their **experiences of being captured by German U-boats under the Cruiser Rules.** The SS Linda Blanche was sunk by U-31 on January 30, 1915. One of the crewmen related what happened once the U-boat surfaced, announced they had been captured, examined the papers, and determined it was an unarmed merchant ship:

The mate [who] was in charge of the boat that passed between the Linda Blanche, and the submarine, said the German officers were jolly chaps and quite young, too. They could speak English well, and they gave the crew half a box of cigars and some cigarettes. One Welshman got a muffler, another a pair of strong suede gloves, and the cabin boy, a little chap of 15, who was made much of because he was in tears, got a cap and a pair of mittens from the submarine crew. He laughed when he got back to land, and was comparatively happy when he went off to his Welsh home by train.

The quartermaster of the SS Ben Cruachan, which was sunk by the U-21 on that same day in a manner similar to that of the SS Linda Blanche, explained how they were treated by the German submariners:

It was about 10:00 o'clock when the submarine was sighted and we should have been in Liverpool at 2 o'clock. When we were held up the crew got into two large lifeboats and two small boats.

The report that our ship was torpedoed is not correct. They blew her up by a bomb which was carried aboard and placed at the stern end. There was a long fuse which ran over the side of the ship and reached almost down to the level of the water. When everybody had got off one of the submarine crew applied a light to it.

The quartermaster added:

**The Germans were very decent to us. They told us where we could find a trawler fleet.** The chief officer of the submarine shook hands with our skipper and said "I am very sorry, Captain, but war is war." When our skipper got off the submarine into the lifeboat the German crew stood at salute and the chief officer shouted, "I hope you will all get picked up before bad weather comes on."

### British Ignore the Rules of War Putting Innocent People at Risk

The British learned early in the war that they had underestimated the capabilities of the German U-boats, and Britain needed an answer to them. One of the early answers was the **Q-boat**. These were merchant ships retrofitted with hidden armaments, or specially designed military ships with panels hiding the armaments making them appear to be merchant vessels. They got the nickname Q-boats (or Q-ships) because their homeport was in Queenstown, Ireland.

**One problem with the British Q-boats was that their very existence was a violation of one of the rules of war, the Cruiser Rules, because it blurred the distinction between a warship and a noncombatant merchant vessel.** Once it became known that the British had violated the Cruiser Rules by deploying warships disguised as noncombatant merchant ships, Germany was no longer legally bound by the Cruiser Rules to treat merchant ships as unarmed noncombatants.

Within days Kaiser Wilhelm II traveled to the naval station at Wilhelmshaven. On February 4, the German Admiralty issued a war zone decree. The next day's New York Times printed much of it on the front page:

The waters around Great Britain and Ireland, including the whole English Channel, are declared a war zone from and after Feb. 18, 1915.

Every enemy merchant ship found in this war zone will be destroyed, even if it is impossible to avert dangers which threaten the crew and passengers.

Also, neutral ships in the war zone are in danger, as in consequence of the misuse of neutral flags, ordered by the British Government on Jan. 31, and in view of the hazards of naval warfare, it cannot always be avoided that attacks meant for enemy ships endanger neutral ships.

Prior to the Lusitania's departure from New York on May 1, 1915 — her last voyage — the German government issued official warnings and even paid for advertisements warning prospective passengers that the waters around the British Isles were a war zone.

Germany's ill-advised war zone reaction to catching the British red-handed was one of the biggest blunders of World War I. Germany should have used this in psychological warfare. They had the evidence they needed to influence neutral nations to take action against Britain. They could have pointed out the endangerment of 15-year-old cabin boys by ordering noncombatant merchant vessels to attempt to ram U-boats, thereby revoking their status as noncombatants. Instead, the German leaders chose a military reaction that backfired in two ways: It alienated the very people they were trying to influence, and the emotional headlines of war got the front page news while articles of substance, if reported all, were frequently pushed to the back pages.

### Lucitania Is Specifically Made a Target by Name by Making It Known It Is Violating the Cruiser Rules

For the Germans to sink any neutral ship, or any foreign ship that was claimed to have American passengers would not be enough to make the majority of the American public instantly outraged and call for war after hearing news. If American citizens heard about a foreign ship previously unknown to them, that was not known for carrying American passengers which was sunk by a German u-boat, they would be able to understand the possibility of the ship being accidentally sunk by the Germans because they too were unaware of the ships history and it's carrying of American passengers. Within days of the heightened awareness of England's bizarre foreign policy, **the British ship Lusitania was observed sailing under an American flag.**

The incident was reported to the New York Times by three American citizens who were on board and requested their names not be published. The February 7 front-page article contained Lusitania Captain David Dow's explanation that he changed flags because he had received a warning that U-boats were in the area. Captain Dow defended his actions by saying part of the ship's cargo was mail of neutral nations and some of the passengers were citizens of neutral nations.

And Not Discouraging the British from Flying the American Flag on Their Ships

Now President Wilson has to link the sinking of the Lusitania to the reaction of going to war when it is sunk. To do this he tells the Germans that if they sink any American flagged ship even if it is not really an American ship and Americans are killed, the Germans will be held strictly accountable. And then the British and Americans sail a British ship with an American flag carrying American passengers into a known u-boat area of operation. The story gets even worse as you will see in the following paragraphs. On February 10, under public pressure, President Wilson sent notes to both the British and German governments. His note to the German government is known as the Strict Accountability note. If any German naval commander, assuming a ship flying a U.S. flag is not an American ship, sinks an American ship or takes the life an American, the German government will be held strictly accountable.

Wilson's note to the British government soft-pedaled their use of the U.S. flag, essentially giving the British a tacit go-ahead to continue doing it. James Perloff, in "False Flag at Sea — Lusitania," lists among the items illegally on board guncotton, a high explosive used by the British when manufacturing military mines. According to Perloff:

In the U.S. Justice Department's archives is an affidavit signed by Dr. E. W. Ritter von Rettegh, a chemist employed by Captain Guy Gaunt, the British naval attaché in Washington. Ritter von Rettegh stated that Gaunt called him to his office on April 26, 1915, and asked what the effect would be of sea water coming into contact with guncotton. The chemist explained that **there were two types of guncotton — trinitro cellulose, which seawater would not affect, and pyroxylene, which sea water could cause to suddenly explode,** as a result of chemical changes that he explained in technical detail.

The following day, **Gaunt visited the Du Pont munitions plant in Cristfield, New Jersey, and Du Pont thereupon shipped tons of pyroxylene, packaged in burlap, to the Cunard wharf in New York City, where it was loaded onto the Lusitania.** It quite evidently accounts for the item on the ship's manifest of 3,813 40-pound containers of "cheese," which were shipped along with 696 containers of "butter." That these packages were not butter and cheese is clear: they were not shipped in refrigerated compartments; their destination was listed as the Royal Navy's Weapons Testing Establishment; and no one filed an insurance claim for the lost "butter and cheese."

**it was a violation of the intent of the Passenger Act of 1882 for a ship coming into or departing from a U.S. port to have both passengers and explosive cargo on board.**

"When I was landed in Queenstown after the sinking of the Lusitania," said Mr. Gauntlett, "I was very much surprised to find **several torpedo boat destroyers inside the harbor** which were under the orders of a superannuated naval officer. This note also included **a formal offer by the German government to have the Lusitania incident investigated** by "an international call on the International Commission of Inquiry, as provided by Article III. of The Hague agreement of Oct. 18, 1907." Germany was willing, if found wrong, to be held responsible for the sinking and pay compensation. Secretary of State William Jennings Bryan was willing to accept the German offer, but President Wilson refused.

An investigation under Article 3 of The Hague agreement in a neutral country could have asked why the British Navy withdrew its convoy ship, the Juno, and then ordered it back to port without rescuing survivors. It could have asked about the butter and cheese. It could have questioned dockworkers to identify the dairy that supplied the dairy products that didn't need refrigeration. It could have asked whether or not the Lusitania had been retrofitted with artillery at Queenstown, making it a Q-boat.

Of course, **the collector of customs, Dudley Field Malone, who was appointed by President Wilson, didn't question the lack of refrigeration for the dairy products**. **The Zimmermann Telegram** (or Zimmermann Note or Zimmerman Cable) was a secret diplomatic communication issued from the German Foreign Office in January 1917 that **proposed a military alliance between Germany and Mexico if the United States entered World War I** against Germany. - H. Completely embargo all trade with Japan, in collaboration with a similar embargo imposed by the British Empire.<sup>4</sup>

**The bait offered Japan was our Pacific Fleet.** In 1940, Admiral J.O. Richardson, the fleet's commander, flew to Washington to protest [president] FDR's decision to permanently base the fleet in Hawaii instead of its normal berthing on the U.S. West Coast.

The admiral had sound reasons: Pearl Harbor was vulnerable to attack, being approachable from any direction; it could not be effectively rigged with nets and baffles to defend against torpedo planes; and in Hawaii it would be hard to supply and train crews for his undermanned vessels. Pearl Harbor also lacked adequate fuel supplies and dry docks, and keeping men far from their families would create morale problems. The argument became heated. Said Richardson: "I came away with the impression that, despite his spoken word, the President was fully determined to put the United States into the war if Great Britain could hold out until he was reelected."

**Richardson was quickly relieved of command.** Replacing him was Admiral Husband E. Kimmel. Kimmel also informed Roosevelt of Pearl Harbor's deficiencies, but accepted placement there, trusting that Washington would notify him of any intelligence pointing to attack. This proved to be misplaced trust. As Washington watched Japan preparing to assault Pearl Harbor, Admiral Kimmel, as well as his Army counterpart in Hawaii, General Walter C. Short, were completely sealed off from the information pipeline.

### Japanese Naval and Diplomatic Codes Were Broken

When a military breaks the codes of another military they want to keep the enemy from changing their codes so they don't have to break them again. The military has to be careful not to act in a way that would make their enemy ask: "why would they do that? Do they know what we are planning? General Marshal convinced Thomas not to tell because the war was not over and it would cause the Japanese to change their codes. General Marshal was also the person who delayed sending the warning by fifteen hours to Pearl Harbor on the day of the attack because he was part of the conspiracy.

*Late on December 6 and in the very early morning hours of December 7 the United States intercepted messages sent to the Japanese ambassador in Washington. These messages were basically a declaration of war—Japan was saying it was breaking off negotiations with America. At those times, General Marshall and President Roosevelt were shown the intercepts. When FDR read them he said, “This means war.” When the last intercept was shown to Roosevelt it was still hours before the Pearl Harbor attack. And then General Marshall, though, sat on the message for about fifteen hours because he didn't want to send...he didn't want to warn the Hawaiian commanders in time....he didn't want them to interfere with the overt act. **Roosevelt saw it too.** *They should have sent an emergency warning to Admiral Kimmel in Hawaii, right?*

*Your book claims that in 1941 Japan had a spy residing in the Japanese consulate in Honolulu.*

However, none of this information was passed to our commanders in Hawaii, Kimmel and Short, with the exception of Ambassador Grew's January warning, a copy of which reached Kimmel on February 1st. To allay any concerns, Lieutenant Commander McCollum — who originated the plan to incite Japan to war — wrote Kimmel: "Naval Intelligence places no credence in these rumors. Furthermore, based on known data regarding the present disposition and deployment of Japanese naval and army forces, no move against Pearl Harbor appears imminent or planned for in the foreseeable future."

1941 also witnessed the following 5 warnings:

On January 27th, our ambassador to Japan, Joseph Grew, sent a message to Washington stating: "The Peruvian Minister has informed a member of my staff that he has heard from many sources, including a Japanese source, that in the event of trouble breaking out between the United States and Japan, the Japanese intended to make a surprise attack against Pearl Harbor with all their strength...."

On November 3rd, still relying on informants, Grew notified Secretary of State Cordell Hull: "War with the United States may come with dramatic and dangerous suddenness." He sent an even stronger warning on November 17th.

Congressman Martin Dies would write:

Early in 1941 the Dies Committee came into possession of a strategic map which gave clear proof of the intentions of the Japanese to make an assault on Pearl Harbor. The strategic map was prepared by the Japanese Imperial Military Intelligence Department. As soon as I received the document I telephoned Secretary of State Cordell Hull and told him what I had. Secretary Hull directed me not to let anyone know about the map and stated that he would call me as soon as he talked to President Roosevelt. In about an hour he telephoned to say that he had talked to Roosevelt and they agreed that it would be very serious if any information concerning this map reached the news services.... I told him it was a grave responsibility to withhold such vital information from the public. The Secretary assured me that he and Roosevelt considered it essential to national defense.

Dusko Popov was a Yugoslav who worked as a double agent for both Germany and Britain. His true allegiance was to the Allies. In the summer of 1941, the Nazis ordered Popov to Hawaii to make a detailed study of Pearl Harbor and its nearby airfields. The agent deduced that the mission betokened a surprise attack by the Japanese. In August, he fully reported this to the FBI in New York. J. Edgar Hoover later bitterly recalled that he had provided warnings to FDR about Pearl Harbor, but that Roosevelt told him not to pass the information any further and to just leave it in his (the president's) hands.

Kilsoo Haan, of the Sino-Korean People's League, received definite word from the Korean underground that the Japanese were planning to assault Hawaii "before Christmas." In November, after getting nowhere with the State Department, Haan convinced Iowa Senator Guy Gillette of his claim's merit. Gillette briefed the president, who laconically thanked him and said it would be looked into.

In Java, in early December, the Dutch Army decoded a dispatch from Tokyo to its Bangkok embassy, forecasting attacks on four sites including Hawaii. The Dutch passed the information to Brigadier General Elliot Thorpe, the U.S. military observer. Thorpe sent Washington a total of four warnings. The last went to General Marshall's intelligence chief. Thorpe was ordered to send no further messages concerning the matter. The Dutch also had their Washington military attaché, Colonel Weijerman, personally warn General Marshall.

### Pearl Not Was Allowed To Defend Itself

To make sure that the Japanese have a successful attack and kill as many Americans as possible and destroy as much equipment as possible, the N.W.O. took steps to make sure that Pearl Harbor would not be able to defend itself to the best of its ability.

However, although **three Purple decoding machines were allotted to Britain, none was sent to Pearl Harbor**. Intercepts of ciphered messages radioed between Tokyo and its Honolulu consulate had to be forwarded to Washington for decrypting. Thus Kimmel and Short, the Hawaiian commanders, were at the mercy of Washington for feedback. **A request for their own decoding machine was rebuffed on the grounds that diplomatic traffic was of insufficient interest to soldiers.**

During the week before December 7th, naval aircraft searched more than two million square miles of the Pacific — but never saw the Japanese force. This is because Kimmel and Short had only enough planes to survey one-third of the 360-degree arc around them, and **intelligence had advised (incorrectly) that they should concentrate on the Southwest.**

Radar, too, was insufficient. There were not enough trained surveillance pilots. Many of the reconnaissance craft were old and suffered from a lack of spare parts. **The commanders' repeated requests to Washington for additional patrol planes were turned down**. Rear Admiral Edward T. Layton, who served at Pearl Harbor, summed it up in his book *And I Was There*: "There was never any hint in any intelligence received by the local command of any Japanese threat to Hawaii. Our air defenses were stripped on orders from the army chief himself. Of the twelve B-17s on the island, **only six could be kept in the air by cannibalizing the others for spare parts.**"

They were not allowed to patrol the sea around them even though they had an entire fleet of ships. They were told to just sit there.

The Navy has traditionally followed the rule that, when international relations are critical, the fleet puts to sea. That is exactly what Admiral Kimmel did. **Aware that U.S.-Japanese relations were deteriorating, he sent 46 warships safely into the North Pacific** in late November 1941 — without notifying Washington. He even ordered the fleet to conduct a mock air raid on Pearl Harbor, clairvoyantly selecting the same launch site Admiral Yamamoto chose two weeks later.

**When the White House learned of Kimmel's move it countermanded his orders and ordered all ships returned to dock**, using the dubious excuse that Kimmel's action might provoke the Japanese. Washington knew that if the two fleets met at sea, and engaged each other, there might be questions about who fired the first shot.

Pearl Harbor was told to protect itself from sabotage which put their planes at very high risk from the Japanese bombers. Sabotage was very unlikely but bombing was imminent.

**"Continental districts, Guam, Samoa take measures against sabotage."** The message further stated that "measures should be carried out so as not repeat not to alarm civil population." Both commanders reported the actions taken to Washington. **Short followed through with sabotage precautions, bunching his planes together (which hinders saboteurs but makes ideal targets for bombers)**, and Kimmel stepped up air surveillance and sub searches. If their response to the "war warning" was insufficient, Washington said nothing. **The next day, a follow-up message** from Marshall's adjutant general to Short warned only: "Initiate forthwith all additional measures necessary to **provide for protection of your establishments, property, and equipment against sabotage**, protection of your personnel against subversive propaganda and protection of all activities against espionage."

#### Kimmel and Short Set Up As Patsies for the Attack

**It was clear, of course, that once disaster struck Pearl Harbor, there would be demands for accountability.** Washington seemed to artfully take this into account by sending an ambiguous "war warning" to Kimmel, and a similar one to Short, on November 27th. **This has been used for years by Washington apologists to allege that the commanders should have been ready for the Japanese.**

Indeed, the message began conspicuously: "This dispatch is to be considered a war warning." But it went on to state: "The number and equipment of Japanese troops and the organizations of naval task forces indicates an amphibious expedition against the Philippines, Thai or Kra Peninsula, or possibly Borneo." **None of these areas was closer than 5,000 miles to Hawaii! No threat to Pearl Harbor was hinted at.**

#### Pacific Cleared Of Shipping

On November 25th, approximately **one hour after the Japanese attack force left port for Hawaii, the U.S. Navy issued an order forbidding U.S. and Allied shipping to travel via the North Pacific.** All transpacific shipping was rerouted through the South Pacific. This order was even applied to Russian ships docked on the American west coast. The purpose is easy to fathom. **If any commercial ship accidentally stumbled on the Japanese task force, it might alert Pearl Harbor.** As Rear Admiral Richmond K. Turner, the Navy's War Plans officer in 1941, frankly stated: "**We were prepared to divert traffic when we believed war was imminent. We sent the traffic down via the Torres Strait, so that the track of the Japanese task force would be clear of any traffic.**"

McNamara said he and president Johnson and dean rusk, the secretary of state 1961-69, all agreed that if israel called for help from the US to fight, they had to be in position where the American people and congress would support the war. **They said if israel started the war the would not get support.**

Egypt had told Israel that their ships would be blocked from going through the Straits of Tiran and then started massing troops on its border with Israel which was a provocation but it was Israel that attacked first. Israel lied and said it was Egypt that attacked first but later admitted they did first.

In the months prior to June 1967, tensions became dangerously heightened. Israel reiterated its post-1956 position that the closure of the Straits of Tiran to Israeli shipping would be a cause for war (a *casus belli*).

Egyptian President Gamal Abdel Nasser announced in May that the Straits would be closed to Israeli vessels, and then mobilised Egyptian forces along the border with Israel, ejecting UNEF. On 5 June, Israel launched a series of airstrikes against Egyptian airfields, initially claiming that it had been attacked by Egypt, but later stating that the airstrikes were preemptive. The question of which side caused the war is one of a number of controversies relating to the conflict.

The USS Liberty was sent unprotected close to a war-zone.

Analyst: Israelis wanted it sunk

The transcript published by the Jerusalem Post bore scant resemblance to the one that in 1967 rolled off the teletype machine behind the sealed vault door at Offutt Air Force Base in Omaha, where Steve Forslund worked as an intelligence analyst for the 544th Air Reconnaissance Technical Wing, then the highest-level strategic planning office in the Air Force.

"The ground control station stated that the target was American and for the aircraft to confirm it," Forslund recalled. "The aircraft did confirm the identity of the target as American, by the American flag.

"The ground control station ordered the aircraft to attack and sink the target and ensure they left no survivors."

Forslund said he clearly recalled "the obvious frustration of the controller over the inability of the pilots to sink the target quickly and completely."

"He kept insisting the mission had to sink the target, and was frustrated with the pilots' responses that it didn't sink."

Nor, Forslund said, was he the only member of his unit to have read the transcripts. "Everybody saw these," said Forslund, now retired after 26 years in the military.

Forslund's recollections are supported by those of two other Air Force intelligence specialists, working in widely separate locations, who say they also saw the transcripts of the attacking Israeli pilots' communications.

One is James Gotcher, now an attorney in California, who was then serving with the Air Force Security Service's 6924th Security Squadron, an adjunct of the NSA, at Son Tra, Vietnam.

"It was clear that the Israeli aircraft were being vectored directly at USS Liberty," Gotcher recalled in an e-mail. "Later, around the time Liberty got off a distress call, the controllers seemed to panic and urged the aircraft to 'complete the job' and get out of there."

Lieutenant Commander David E. Lewis, USS Liberty's chief intelligence officer (who was severely wounded in the attack) has reported a conversation with Admiral Lawrence R. Geis, the Sixth Fleet carrier division commander, who visited Lewis after he had been medically evacuated by helicopter to the aircraft carrier USS America. According to Lewis, "He (Admiral Geis) said that he wanted somebody to know that we weren't forgotten" attempts HAD been made to come to our assistance. He said that he had launched a flight of aircraft to come to our assistance, and he had then called Washington. Secretary McNamara came on the line and ordered the recall of the aircraft, which he did. After the second launch, he again called Washington to let them know what was going on. Again, Secretary McNamara ordered the aircraft recalled.

Not understanding why, he requested confirmation of the order; and the next higher in command came on to confirm that "President Johnson...with the instructions that the aircraft were to be returned, that he would not have his allies embarrassed, he didn't care who was killed or what was done to the ship" words" to that effect. With that, Admiral Geis swore me to secrecy for his lifetime. I had been silent up until I found out from Admiral Moorer that Admiral Geis had passed away" [transcript from NBC's Liberty Story, aired on national television 1/27/92]. This statement by Commander Lewis has recently been corroborated by Tony Hart, a Navy communications technician stationed at the U.S. Navy Base in Morocco in June, 1967. Mr. Hart connected the telephone conversation between Secretary McNamara and Admiral Geis and stayed on the line to keep them connected. Hart has been recorded as saying that he overheard Admiral Geis refusing McNamara's order to recall the Sixth Fleet rescue aircraft while the ship was under attack. Mr. Hart reported that McNamara responded, "we are not going to war over a bunch of dead sailors."

Here is an interesting point. Both McNamara and President Johnson didn't want to go to war over a bunch of dead sailors as they claim. What they were more likely trying to do was cover up what happened because no one expected the USS liberty to call for help or even survive after six torpedoes were fired at it. One set of transcripts apparently survived in the archives of the U.S. Army's intelligence school, then located at Ft. Holabird in Maryland.

W. Patrick Lang, a retired Army colonel who spent eight years as chief of Middle East intelligence for the Defense Intelligence Agency, said the transcripts were used as "course material" in an advanced class for intelligence officers on the clandestine interception of voice transmissions.

Asked whether the NSA had in fact intercepted the communications of the Israeli pilots who were attacking the Liberty, Kirby, the retired senior NSA official, replied, "We sure did."

On its Web site, the NSA has posted three recordings of Israeli communications made on June 8, 1967. But none of the recordings is of the attack itself.

The three recordings reflect what the NSA describes as "the aftermath" of the attack -- Israeli communications with two Israeli helicopters dispatched to rescue any survivors who may have jumped into the water.

Two of the recordings were made by Michael Prostnik, a Hebrew linguist aboard a U.S. Navy EC-121, a lumbering propeller-driven aircraft specially equipped to gather electronic intelligence.

But Prostnik said he was certain that more than three recordings were made that day.

"I can tell you there were more tapes than just the three on the Internet," he said. "No doubt in my mind, more than three tapes."

At least one of the missing tapes, Prostnik said, captured Israeli communications "in which people were not just tranquil or taking care of business as normal. We knew that something was being attacked," Prostnik said. "Everyone we were listening to was excited. You know, it was an actual attack. And during the attack was when mention of the American flag was made."

Prostnik acknowledged that his Hebrew was not good enough to understand every word being said, but that after the mention of the American flag "the attack did continue. We copied [recorded] it until we got completely out of range. We got a great deal of it."

Charles Tiffany, the plane's navigator, remembers hearing Prostinak on the plane's intercom system, shouting, "I got something crazy on UHF," the radio frequency band used by the Israeli Air Force.

"I'll never forget it to this day," said Tiffany, now a retired Florida lawyer. He also remembers hearing the plane's pilot ordering the NSA linguists to "start taping everything."

Prostinak said he and the others aboard the plane had been unaware of the Liberty's presence 15,000 feet below, but had concluded that the Israelis' target must be an American ship. "We knew that something was being attacked," Prostinak said.

**After listening to the three recordings released by the NSA, Prostinak said it was clear from the sequence in which they were numbered that at least two tapes that had once existed were not there.**

One tape, designated A1104/A-02, begins at 2:29 p.m. local time, just after the Liberty was hit by the torpedo. Prostinak said there was a preceding tape, A1104/A-01.

That tape likely would have recorded much of the attack, which began with the air assault at 1:56 p.m. Prostinak said a second tape, which preceded one beginning at 3:07 p.m., made by another linguist aboard the same plane, also appeared to be missing.

Another linguist aboard the EC-121, who spoke on condition that he not be named, said he believed there had been as many as "five or six" tapes recording the attack on the Liberty or its aftermath.

Andrea Martino, the NSA's senior media adviser, did not respond to a question about the apparent conflict between the agency's assertion that there were no recordings of the Israeli attack and the recollections of those interviewed for this article.

**The United Nations resolve to have Palestine partitioned into two states, one Jewish and one Arab**, with Jerusalem to remain as an international zone to be enjoyed by all religious faiths. This transfer is scheduled to take place on May 15th, 1948.

However, just to put into perspective who controls the United Nations (UN), please be aware that the UN had no right to give Arab property to anyone, as indeed even though the Jews owned only 6% of Palestine at that time, resolution 181 granted the **Jews 57% of the land** leaving the Arabs who at that time had 94% with only 43%.

#### Expanding the State of Israel and Removing Non Jews.

Following the United Nations transfer of Palestine to an independent Jewish state and an independent Arab state on May 15th, **the Israelis launch another military assault on the Arabs** (today known as Palestinians) with blaring loudspeakers on their trucks informing the Arabs that **if they do not flee immediately, they will be slaughtered**. 800,000 Arabs with the recent memory of the Deir Yassin massacre at the forefront of their minds, flee in panic. They ask for help from neighbouring Arab states, but those states do not get involved as they are no match for the Israelis whose up to date military hardware had been supplied by the Jewish Stalinist regime in Russia.

Following this series of Jewish genocidal war crimes, the Jews now control 78% of the former Palestine as oppose to the 57% that had already been given to them illegally by the Jewish controlled United Nations. The Arabs, many of them Christians, would never be paid compensation for their homes, property and businesses stolen from them during this genocide, and as a result these people end up in slum refugee cities of tents. Furthermore at least half of the Arabs, in a desperate hurry to flee with their lives, leave their birth certificates behind. The State of Israel then pass a law that only those Arabs who are able to prove their citizenship are allowed to return to their land, now known as Israel, which meant these 400,000 Arabs could not return and lost all the property they had left there.

In the early hours of April 19th, 132 Jewish terrorists from the Irgun gang, led by future Israeli Prime Minister Menachem Begin, and the Stern gang, led by future Israeli Prime Minister Yitzhak Shamir, brutally massacre 200 men, women and children as they are sleeping peacefully in the Arab village of Deir Yassin. In an effort to prevent outside observers discovering the brutality of their war crimes, they try to burn some of the bodies, but when that proves unsatisfactory, they stuff some in a well to hide them from the Red Cross representatives who arrive on the scene the next day and would subsequently tell the world. Indeed reports from survivors can be found in the, “Report of the Criminal Investigation Division,” a Palestine Government Document labelled, No. 179/110/17/GS dated April 13th, 15th, and 16th, 1948, in which British interrogating officer, Assistant Inspector General Richard Catling states,

“The recording of statements is hampered also by the hysterical state of the women, who often break down many times, whilst the statement is being recorded. There is, however, **no doubt that many sexual atrocities were committed by the attacking Jews. Many young school girls were raped and later slaughtered. Old women were also molested.** One story is current concerning a case in which **a young girl was literally torn in two.** Many **infants were butchered and killed.** I also saw one old woman who gave her age as 104, who had been severely beaten about the head with rifle butts. Women had bracelets torn from their arms and rings from their fingers, and parts of some **women's ears were severed in order to remove ear-rings.**”

History shows that this strategy worked by creating Islamic terrorists. Now Israel would use the threat of Islamic terrorism to make themselves look like a victim and keep increasing the military and police state inside Israel preventing Palestine from ever returning. By now time there is even a wall surrounding the state of Israel.

### **Building the International Islamic Terror Network**

By the year 1978 terrorism between Muslims and Jews was well in motion but there wasn't an international network of islamist terrorists. There were a few one off international attacks before this time but there wasn't an organized and co-coordinated network. The N.W.O. would now create a new international islamist terrorist network to be used for some specific goals they had for the future.

They also created an organization called the Trilateral Commission in 1973 to start building their global structures like a one world financial system and to start bringing the individual sovereign nations fully under the control of the United Nations by promoting internationalism in business and industry. Their world government will be a technocracy.

One of the final goals of the N.W.O. is to set up a technocracy (technocratic society) that is controlled by the 'elite' and by technical experts that will know everything about you and totally control you. This goal requires total surveillance of you. How else will they know everything about you if they can't totally watch you and track you and trace your contacts? This technocracy is for control of the entire earth but to set up a global surveillance grid there has to be a reason. That reason was the global war on terror and that war required an international Islamist terrorism network to go to war against. Also, Anti-terrorism laws will be used to stop anyone who opposes the N.W.O. by calling them a domestic terrorist if they are trying to save their nation from being taken over by the N.W.O.

The N.W.O. would use the three main divisions of people who are the communists, the Muslims and the Judeo-Christian to make this plan happen by creating conflicts between them. At the same time, the capacity to assert social and political control over the individual will vastly increase. As I have already noted, it will soon be possible to assert almost continuous surveillance over every citizen and to maintain up-to-date, complete files, containing even most personal information about the health or personal behaviour of the citizen, in addition to more customary data. These files will be subject to instantaneous retrieval by the authorities.

### The Steps to Start Merging the World Into a One World System Controlled By the N.W.O.

Before we look at how the international terrorism helped set up the global surveillance network we will look at how the N.W.O. also brought nations under the control of their world government. The global surveillance and technocracy are meant to keep the nations under the control of their world government.

In short, the "house of world order" will have to be built from the bottom up rather than from the top down. Of course, for political as well as administrative reasons, some of these specialized arrangements should be brought into an appropriate relationship with the central institutions of the U.N. system, but the main thing is that the essential functions be performed.

The People's Democratic Party of Afghanistan (PDPA) was officially formed at the unity congress of the different factions of the Socialist Party of Afghanistan on 1 January 1965. This caused unrest and quickly expanded into a state of civil war by 1979, waged by guerrilla mujahideen (and smaller Maoist guerillas) against regime forces countrywide. It quickly turned into a proxy war as the **Pakistani government provided these rebels with covert training centers, the United States supported them through Pakistan's Inter-Services Intelligence (ISI)**, and the Soviet Union sent thousands of military advisers to support the PDPA regime

The revolution also introduced severe repression of a kind previously unknown in Afghanistan. According to journalist and CNAS member Robert D. Kaplan, while Afghanistan had historically been extremely poor and underdeveloped, it "had never known very much political repression" until 1978. The soldiers' knock on the door in the middle of the night, so common in many Arab and African countries, was little known in Afghanistan, where a central government simply lacked the power to enforce its will outside of Kabul. Taraki's coup changed all that. Between April 1978 and the Soviet invasion of December 1979, Afghan communists executed 27,000 political prisoners at the sprawling Pul-i-Charki prison six miles east of Kabul. Many of the victims were village mullahs and headmen who were obstructing the modernization and secularization of the intensely religious Afghan countryside. By Western standards, this was a salutary idea in the abstract. But it was carried out in such a violent way that it alarmed even the Soviets. — Robert D. Kaplan, Soldiers of God: With Islamic Warriors in Afghanistan and Pakistan,

Kaplan states that it was the Saur Revolution and its harsh land reform program, rather than the December 1979 Soviet invasion "as most people in the West suppose", that "ignited" the mujahidin revolt against the Kabul authorities and prompted the refugee exodus to Pakistan.

Former CIA director Robert Gates states in his memoirs: The American secret services began six months before the Soviet intervention to support the Mujahideen [in Afghanistan]. At that time you were president Carter's security advisor; thus you played a key role in this affair. Do you confirm this statement?

"We now have the opportunity to provide the USSR with their Viet Nam war."

**Three weeks after Soviet tanks rolled into Kabul, Carter's secretary of defense, Harold Brown, was in Beijing arranging for a weapons transfer from the Chinese to the CIA-backed Afghani troops mustered in Pakistan.**

The Chinese, who were generously compensated for the deal, agreed and even consented to send military advisers. Brown worked out a similar arrangement with Egypt to buy \$15 million worth of weapons. **"The U.S. contacted me," [then-Egyptian president] Anwar Sadat recalled** shortly before his assassination [in 1981]. "They told me, 'Please open your stores for us so that we can give the Afghans the armaments they need to fight.' And I gave them the armaments. **The transport of arms to the Afghans started from Cairo on U.S. planes."**

**With the support of Pakistan's military dictator, General Zia-ul-Haq,** the U.S. began recruiting and training both mujahideen fighters from the 3 million Afghan refugees in Pakistan and large numbers of mercenaries from other Islamic countries. **Estimates of how much money the U.S. government channeled** to the Afghan rebels over the next decade vary, but most sources put the figure between **\$3 billion and \$6 billion, or more.**

**The CIA became the grand coordinator:** purchasing or arranging the manufacture of Soviet-style weapons from Egypt, China, Poland, Israel and elsewhere, or supplying their own; arranging for military training by Americans, Egyptians, Chinese and Iranians; hitting up Middle-Eastern countries for donations, notably Saudi Arabia which gave many hundreds of millions of dollars in aid each year, totaling probably more than a billion; pressuring and bribing Pakistan-with whom recent American relations had been very poor-to rent out its country as a military staging area and sanctuary; putting the Pakistani Director of Military Operations, Brigadier Mian Mohammad Afzal, onto the CIA payroll to ensure Pakistani cooperation.

The U.S. government has been criticized for allowing Pakistan to channel a disproportionate amount of its funding to the controversial Hekmatyar, whom Pakistani officials believed was "their man". Hekmatyar has been criticized for killing other mujahideen and attacking civilian populations, including shelling Kabul with American-supplied weapons, causing 2,000 casualties. Hekmatyar was said to be friendly with Osama bin Laden, founder of al-Qaeda, who was running an operation for assisting "Afghan Arab" volunteers fighting in Afghanistan, called Maktab al-Khadamat. Alarmed by his behavior, Pakistan leader General Zia warned Hekmatyar, "It was Pakistan that made him an Afghan leader and it is Pakistan who can equally destroy him if he continues to misbehave."

### **Creating Al Qaeda and Spreading Terrorist Attacks Internationally**

As we saw the N.W.O. created the conflict that allowed them to start gathering Islamist fighters from different nations even though they had enough Afghans to fight in a conflict that should have never happened in the first place. But at this point they only had people fighting in one location so they had to spread the fighters out around the world and have them commit acts of terrorism to justify the global war on terror that the N.W.O. wanted.

There had to be leaders in the Mujahideen who would eventually want to expand the terror globally after the afghan-soviet war and they would need a base and support network to carry out that operation. Afghanistan and a few other places would be the main base with a network of locations around America to recruit and finance the terrorism. A few years after their Indiana meeting, Azzam and bin Laden co-founded the Services Bureau, an organization in Peshawar, Pakistan, that sought to bring Muslim fighters to Afghanistan. As its leader, Azzam spearheaded a worldwide effort to fundraise and recruit, especially from the Gulf countries and the United States.

Although based in Pakistan from 1981 onward, Azzam crossed the Atlantic at least once a year, and by the end of the decade had visited New York, Texas, California, Seattle, and several other states in between. The message was always the same: Muslims in America should fight in Afghanistan, or at least donate money to the jihad. He spoke not in underground cellars, but in large, open venues, such as the annual meeting of the Muslim Arab Youth Association, which usually brought together hundreds of people. He stayed in the apartments of young local supporters, impressing them with his charisma and humble lifestyle. U.S. authorities became aware of these activities in the late '80s, but did not consider Azzam a threat.

In December 1984, Azzam launched al-Jihad magazine, an Arabic-language monthly aimed at raising awareness of the Afghan cause. Within eight months, the magazine had a U.S. distributor—the Islamic Centre in Tucson, Arizona—and by the late '80s, it had a nationwide network of agents who sold thousands of copies each month and made America one of the magazine's most important markets.

Next, branch offices of the Afghanistan MAK office were opened in America under the name Al Kifah.

Azzam's activities didn't stop there. In late 1987, a group of activists in Brooklyn approached Azzam with a proposition to make their recently established NGO, the al-Kifah Refugee Center, the American branch of the Services Bureau. Azzam was delighted and later wrote the following in *al-Jihad*:

Al-Kifah soon set up regional branches in Atlanta, Boston, Chicago, and Tucson. It even had a national hotline run out of Chicago that people could call to hear a recorded news bulletin about the Afghan jihad.

The efforts paid off: Hundreds of Muslims from all over America joined the Afghan jihad, and some even became prominent figures in the nascent jihadist movement. Wa'il Julaydan became a key fundraiser for the Services Bureau in Peshawar, Muhammad Bayazid became one of the co-founders of al-Qaeda, and Wadih El Hage also joined al-Qaeda; he was later convicted for his involvement in the 1998 East Africa embassy bombings. Americans were a minority in the Afghan Arab community, but their language skills and high level of education gave them an outsize importance.

The United States was the only country outside Pakistan where Azzam was able to set up an official branch of the Services Bureau. Even Saudi Arabia, which generally approved of Azzam's efforts, never allowed him to open an office, and it sometimes canceled his talks. Other Middle Eastern countries were even more hostile. Azzam was able to visit only Saudi Arabia, the United Arab Emirates, Kuwait, Bahrain, and Jordan in the '80s. The rest denied him entry, and Jordan closed the door on him after 1984.

It helped that the Muslim Brotherhood had a strong presence in the United States, especially in Muslim student societies. For example, the guests at the Indianapolis meeting in 1978 were Muslim Brothers.

Al Kifah held at least a dozen terror conferences around America.

(Report later noted that "A number of **important al Qaeda figures** attended the University of Arizona in Tucson or lived in Tucson in the 1980s and early 1990s". The largest branch of al-Khifa was in Brooklyn's Atlantic Avenue, New York (in or next to the Farouq Mosque). **Other branches were in Atlanta, Boston, Chicago, Pittsburgh, and elsewhere.** Officially known as the al-Khifa Refugee Center and the associated Afghan Refugee Services, **the Brooklyn centre provided the interface for "Operation Cyclone"**, the American effort to support the *mujaheddin*. The organization became known as the "Services Office", after its Peshawar original, and worked to raise funds and train recruits for the war effort.

Azzam is believed to have visited from time to time, and bin Laden was numbered among the financial supporters. **Al-Khifa had a training camp (perhaps the "private rifle club") in Connecticut**, where "Recruits received brief paramilitary training and weapons induction, according to evidence in [subsequent terrorist] trials". **Several former members of the "active service" of the CIA were employed there as "expert consultants".**

**Background:** **Maktab al-Khidamat/Al Kifah (MK) is considered to be the pre-cursor organization to al Qaida and the basis for its infrastructure.** MK was initially created by Usama bin Laden's (UBL) mentor, Shaykh Abdullah Azzam, who was also the spiritual founder of Hamas, as an organization to fund mujahideen in the Soviet-Afghan conflict. MK has helped funnel fighters and money to the Afghan resistance in Peshawar, Pakistan, and had established recruitment centers worldwide to fight the Soviets.

### Building a permanent home for Al Qaeda

After the USSR left Afghanistan in 1989, the N.W.O. had to make sure that Al Qaeda was secure and stable so they took steps to give the organization a permanent home in Afghanistan with branch offices in the USA. They didn't want the international fighters to all go home and return to normal because the war was over. They wanted a permanent international Islamist terrorism network.

To do this they planned to have the Taliban take over Afghanistan but there had to be a reason for the Taliban to be accepted by the citizens because the Taliban way of life was different from the traditional afghan way of life. 'Azzam turned against the Pakistanis in 1989, when it became apparent that manipulations by the ISI were causing heavy casualties among the mujahidin, particularly in the ISI-engineered siege of Jalalabad. The ISI was encouraging frontal assaults (of the type discredited in 1914) against reinforced communist positions supported by the Afghan air force. These tactics were a fatal break from the proven hit-and-run guerrilla attacks favored by the mujahidin. Some, like 'Azzam, believed that with the imminent departure of the Russians from Afghanistan, the ISI was seeking to eliminate those factions of the resistance that were not under their control.

During the summer of 1989, 'Azzam attempted to mediate in the dispute between Ahmad Shah Massoud's group and Hekmatyar, always returning to the need for unity among the mujahidin. Later that year a large quantity of explosives was placed beneath the minbar (pulpit) of the mosque in which 'Azzam gave the Friday sermon. The explosives failed to detonate during the service (which would have killed hundreds), but 'Azzam's enemies were not deterred.

As the war ended, a difference in opinion emerged between Azzam and the Egyptian Islamic Jihad (EIJ) led by Ayman al-Zawahiri over the future direction of MAK. Azzam wanted to use the wealth it had generated, and the network it created to help install a pure Islamic government in post-war Afghanistan and opposed "fitna" among Muslims, including attacks against governments of Muslim countries. Al-Zawahiri wanted to use MAK's assets to fund a global jihad, including the overthrow of governments in Muslim countries deemed un-Islamic. Bin Laden, MAK's most important fundraiser, was strongly influenced by Zawahiri, although he remained close to Azzam.

On November 24, 1989, Azzam was killed by the detonation of 3 mines, by unknown assassins. Azzam as well as his 2 sons were killed in the assassination on their way to their local mosque for evening prayers. Following Azzam's death, Osama bin Laden assumed control of MAK and the organization became absorbed into al-Qaeda. Suspects include bin Laden, Ayman al-Zawahiri, competing Afghan militia leaders, Pakistani Interservices Intelligence Agency, the CIA, the Israeli Mossad, and Iranian intelligence.

Abdullah Azzam was killed In late 1989. his murder was unsolved. Usama Bin laden took over MAK in pakistan.

After Azzam was killed in 1989, UBL and Sheikh Umar Abd al-Rahman (a.k.a. "The Blind Sheikh") continued to use MK to recruit fighters for the Soviet-Afghan conflict. Sheikh Umar Abd al-Rahman was implicated in the 1993 World Trade Center bombing and has been convicted for unrelated crimes pertaining to planning terrorist attacks in the New York area. MK is known to have provided funds and other support to several charities, including the Al Haramain Foundation (AHF) and the Global Relief Foundation.

The CIA backed Hekmatyar prevented a peaceful resolution to the afghan-soviet war by continuing to attack kabul even after the communist government that the soviets were supporting was gone. Gulbuddin Hekmatyar, "a particularly fanatical fundamentalist and woman-hater." According to journalist Tim Weiner, "[Hekmatyar's] followers first gained attention by throwing acid in the faces of women who refused to wear the veil. CIA and State Department officials I have spoken with call him 'scary,' 'vicious,' 'a fascist,' 'definite dictatorship material.'

As the Russians withdrew from Afghanistan in early 1989, American policymakers celebrated with champagne, while the country itself collapsed into virtual anarchy. Almost a quarter of the population was living in refugee camps and most of the country was in ruins. Different factions of the mujahideen struggled for power in the countryside, while the government of Muhammed Najibullah, the last Soviet-installed president controlled Kabul. Eventually, in April 1992, Kabul fell to some of the mujahideen factions and Burhannudin Rabbani was de dared president, but civil war continued unabated. Hekmatyar in particular was dissatisfied with the new distribution of power. With his huge stock of U.S.-supplied weapons, he began an artillery and rocket assault on Kabul that lasted for almost three years, even after he was appointed prime minister in 1993. "The barrage...killed more than 10,000 Afghans [drove] hundreds of thousands into squalid refugee camps, created political chaos, and blocked millions of exiles from returning." The rest of the country disintegrated into isolated fiefdoms dominated by local warlords.

The taliban were the refugees from afghanistan but they were disconnected from their history and indoctrinated with salafism/wahabism that was foreign to afghan culture, the same goal as Al Qaeda. The taliban were supported by the Pakistan army when they came to afghanistan.

In 1994, a new group, the Taliban (Pashtun for "students"), emerged on the scene. Its members came from madrassas set up by the Pakistani government along the border and funded by the U.S., Britain, and the Saudis, where they had received theological indoctrination and military training. Thousands of young men-refugees and orphans from the war in Afghanistan-became the foot soldiers of this movement:

These boys were from a generation who had never seen their country at peace-an Afghanistan not at war with invaders and itself. They had no memories of their tribes, their elders, their neighbors nor the complex ethnic mix of peoples that made up their villages and their homeland. These boys were what the war had thrown up like the sea's surrender on the beach of history ...

They were literally the orphans of war, the rootless and restless, the jobless and the economically deprived with little self-knowledge. They admired war because it was the only occupation they could possibly adapt to. Their simple belief in a messianic, puritan Islam which had been drummed into them by simple village mullahs was the only prop they could hold on to and which gave their lives some meaning. Untrained for anything, even the traditional occupations of their forefathers such as farming, herding or the making of handicrafts, they were what Karl Marx would have termed Afghanistan's lumpen proletariat.

With the aid of the Pakistani army, the Taliban swept across most of the exhausted country promising a restoration of order and finally capturing Kabul in September 1996. The Taliban imposed an ultra-sectarian version of Islam, closely related to Wahhabism, the ruling creed in Saudi Arabia. Women have been denied education, health care, and the right to work.

They must cover themselves completely when in public. Minorities have been brutally repressed. Even singing and dancing in public are forbidden.

Al Qaeda was now an international organization.

During the visit, Casey startled his Pakistani hosts by proposing that they take the Afghan war into enemy territory -- into the Soviet Union itself.

Casey wanted to ship subversive propaganda through Afghanistan to the Soviet Union's predominantly Muslim southern republics. The Pakistanis agreed, and the CIA soon supplied thousands of Korans, as well as books on Soviet atrocities in Uzbekistan and tracts on historical heroes of Uzbek nationalism, according to Pakistani and Western officials.

One source of jitters was that Pakistani intelligence officers -- partly inspired by Casey -- began independently to train Afghans and funnel CIA supplies for scattered strikes against military installations, factories and storage depots within Soviet territory.

The attacks later alarmed U.S. officials in Washington, who saw military raids on Soviet territory as "an incredible escalation," according to Graham Fuller, then a senior U.S. intelligence official who counseled against any such raids. Fearing a large-scale Soviet response and the fallout of such attacks on U.S.-Soviet diplomacy, the Reagan administration blocked the transfer to Pakistan of detailed satellite photographs of military targets inside the Soviet Union, other U.S. officials said.

To Yousaf, who managed the Koran-smuggling program and the guerrilla raids inside Soviet territory, the United States ultimately "chickened out" on the question of taking the secret Afghan war onto Soviet soil. Nonetheless, Yousaf recalled, Casey was "ruthless in his approach, and he had a built-in hatred for the Soviets."

The CIA decided that bin Laden's "Arab Afghans" were too useful an ally to abandon after the Soviets left Afghanistan, and in a meeting at Green's Hotel, Peshawar, Pakistan, in late 1991, between their local representatives, Prince Turki bin Faisal (head of the Saudi intelligence service) and the "Arab Afghans", they decided to continue links. The "strategic" position of Afghanistan vis-a-vis Central Asian oil was a factor in this decision.

The Council on Foreign Relations, a highly influential Washington DC think tank, has called on the Obama administration to ‘befriend’ a terrorist group in Syria which has pledged allegiance to Al-Qaeda leader Ayman al-Zawahiri and whose leader helped plan the 9/11 attacks.

An al Qaeda-Linked Group Worth Befriending

In his recent interview with The New Yorker, U.S. President Barack Obama drew a striking comparison between the Los Angeles Lakers and al Qaeda. “[I]f a jayvee team puts on Lakers uniforms,” he said, “that doesn’t make them Kobe Bryant.” Similarly, he went on to explain, there is a “distinction between the capacity and reach of [and Osama] bin Laden and a network that is actively planning major terrorist plots against the homeland versus jihadists who are engaged in various local power struggles and disputes, often sectarian.”

This flap could not have been timelier. The al Qaeda of yesterday is gone. What is left is a collection of many different splinter organizations, some of which have their own -- and profoundly local -- agendas. The U.S. response to each should be, as Obama put it, “defined and specific enough that it doesn’t lead us to think that any horrible actions that take place around the world that are motivated in part by an extremist Islamic ideology are a direct threat to us or something that we have to wade into.”

..... Does the United States have a stake in the outcome of an intra-al Qaeda struggle? Should it adopt a position of “A pox on both their houses”? Or is one affiliate less threatening than the other, and therefore **worth ignoring for tactical reasons?**

As if these issues were not complex enough, there is another: **the United States should consider whether the fight against al Qaeda is always the strategic priority in the Middle East. It might at times get in the way of other goals, including the efforts to contain Iran and Syria**, themselves state sponsors of terrorism with considerable blood on their hands. For example, an exclusive focus on al Qaeda in Syria could leave Iran relatively better off, which could be equally detrimental to the long-term interests of the United States.

..... ISIS is an **indiscriminate killer of Syrian civilians** and, finally, it is the primary conduit through which **the conflict in Syria is spreading to al-Anbar in Iraq**. The Islamic Front, including Ahrar al-Sham, represents the best hope in Syria for defeating ISIS.

.....Finally, **Ahrar al-Sham's leader, Hassan Abboud, has never endorsed bin Laden's vision of a global jihad**. His struggle is limited to Syria. Designating his group as a terrorist organization might backfire by pushing it completely into al Qaeda's camp.

.....Some will say that the United States' hands are in a bind; **public confirmation that an al Qaeda operative is a senior leader in one of the Islamic Front's most important factions is hard to overlook**. But Obama has more discretion when it comes to designating terrorist organizations than one might think.

..... **the designation of foreign terrorist groups should be seen as a tactic in the service of a larger strategy -- a tool in the hands of a discriminating president.**

The Citizens Commission on Benghazi was interviewed by World Net Daily and they tell us how the Obama administration supported Al Qaeda in Syria and Libya. Former CIA officers confirm the USA was shipping weapons to Al Qaeda.

**Generals conclude Obama backed al-Qaida**

The Obama White House and the State Department under the management of Secretary of State Hillary Clinton **“changed sides in the war on terror” in 2011** by implementing a policy of facilitating the **delivery of weapons to the al-Qaida-dominated rebel militias in Libya attempting to oust Moammar Gadhafi from power**, the Citizens Commission on Benghazi concluded in its interim report.

In WND interviews, **several members of the commission have disclosed their finding that the mission of Christopher Stevens, prior to the fall of Gadhafi and during Stevens' time as U.S. ambassador, was the management of a secret gun-running program operated out of the Benghazi compound**.

The Obama administration's gun-running project in Libya, much like the “fast and furious” program under Eric Holder's Justice Department, operated without seeking or obtaining authorization by Congress.

“The rebels made no secret of their Al Qaeda affiliation, openly flying and speaking in front of the black flag of Islamic jihad, according to author John Rosenthal and multiple media reports,” the interim report said.

"And yet, the White House and senior Congressional members deliberately and knowingly pursued a policy that provided material support to terrorist organizations in order to topple a ruler who had been working closely with the West actively to suppress Al Qaeda."

The report concluded: "The result in Libya, across much of North Africa, and beyond has been utter chaos, disruption of Libya's oil industry, the spread of dangerous weapons (including surface-to-air missiles), and the empowerment of jihadist organizations like Al Qaeda and the Muslim Brotherhood."

In the WND interviews, several members of the citizens' commission, speaking for themselves, not for the commission, added important background to the interim report's conclusion.

Clare Lopez, a member of the commission who served as a career operations officer with the CIA and current is vice president for research at the Washington-based Center for Security Policy.

**"At that time, Stevens was facilitating the delivery of weapons to the al-Qaida-related militia in Libya,"** Lopez continued. "The weapons were produced at factories in Eastern Europe and shipped to a logistics hub in Qatar. The weapons were financed by the UAE and delivered via Qatar mostly on ships, with some possibly on airplanes, for delivery to Benghazi. The weapons were small arms, including Kalashnikovs, rocket-propelled grenades and lots of ammunition."

"This was about weapons going into Libya, and Stevens is coordinating with Abdelhakim Belhadj, the leader of the Libyan Islamic Fighting Group, other al-Qaida-affiliated militia leaders and leaders of the Libyan Muslim Brotherhood that directed the rebellion against Qadhafi as an offshoot of the Egyptian Muslim Brotherhood,"

Kevin Shipp, a former CIA counterintelligence expert who worked on the seventh floor at Langley as protective staff to then-CIA Director William Casey, again speaking for himself in his interview with WND, agreed with Lopez that the gun-running operation Stevens managed is a secret the Obama White House and Clinton State Department have sought to suppress from the public.

"The shocking part, maybe even a violation of international law that the Obama administration has been terrified to have fully revealed, is that Stevens as part of his duties as a State Department employee was assisting in the shipment of arms first into Libya for the al-Qaida-affiliated militia, with the weapons shipped subsequently out of Libya into Syria for use by the al-Qaida-affiliated rebels fighting Assad," Shipp told WND.

"Very possibly, these gun-running activities could be looked at even as treasonable offenses," he said.

### **The Attack on the World Trade Center North Tower in 1993**

The attack on the World Trade Center north tower in 1993 was carried out by terrorists that were part of or connected to the Al Kifah center in Brooklyn, NY, which was part of the CIA Operation Cyclone. ### Why Was the Attack on the North Tower Allowed to Happen?
